Replication Package for "Lives, Livelihoods, and Learning: A Global Perspective on the Well-being Impacts of the Covid-19 Pandemic"

This file explains how to replicate all the figures and tables in the paper "Lives, Livelihoods, and Learning: A Global Perspective on the Well-being Impacts of the Covid-19 Pandemic".

Tables and figures are stored in the directories /Results or /Appendix/Results. For ease of formatting, the tables are generated in the Excel file /Results/Tables123.xlsx (and /Appendix/Results/AppendixTable1.xlsx), which is linked to the Excel files produced by the Stata code in the directory /OutputData.

Replicators attempting to reproduce the results should note that one dataset (Welfare vectors) is not included in the reproducibility package due to data sharing restrictions. Replicators should contact the dataset owners to obtain the corresponding data file and run the entire code. Details on the dataset and data are described below.

Stata code to generate the empirical results

The empirical results in the paper are generated using Stata 17.0 for Mac. Run *ReplicateAllTablesFiguresStata.do* to replicate all the empirical results. This file calls all the Stata do files in the directory /DoFiles or /Appendix/DoFiles with names based on the variable or figure generated by the file (e.g. FigureXX.do, YLL.do, etc.). Next, tables are automatically generated by Excel files located in the directory /Results or Appendix/Results and are linked to the output produced by the corresponding .do files within the OutputData folder. In order to run *ReplicateAllTablesFiguresStata.do*, you will first need to update the directory around line 14 to the location of this replication folder (and *ReplicateAllTablesFiguresStata.do*) on your computer. The programs will save logs in /Logs or /Appendix/Logs.

Replicating individual tables or figures

To produce specific tables or figures, you must initially execute the following .do files—Alpha.do, CPY.do, YLL.do, and FPY.do—located within the /DoFiles directory. These files, when run in any order, will generate the output data inside the /OutputData directory, necessary for the creation of the tables and figures. Tables are automatically generated by the Excel file located in the directory /Results or Appendix/Results (listed below), and are linked to the output produced by the corresponding .do files within the OutputData folder.

Figures can be generated by running the individual .do files listed below. Please note that the directories at the start of each .do file will need to be updated manually, or updated by first running line 14 of *ReplicateAllTablesFiguresStata.do*

Main text tables/figures

The main text results are stored in the files below in the folder /Results:

- Tables 1-3:Results are in the sheets "table1," "table2," and "table3" of Tables123.xlsx. They are generated
by applying formulas to the columns in the "data" sheet of Tables123.xlsx. The data sources for
these columns are as follows:
 - Columns A-F: FPY.xlsx (columns A-E and J).
 - Columns G and H: CPY.xlsx (columns D and E).
 - Column I: YLL.xlsx.
 - Column J: Alpa.xlsx (column O).

These Excel files (FPY.xlsx, CPY.xlsx, YLL.xlsx, and Alpa.xlsx) are created using Stata do files located in the directory /DoFiles. Each Stata do file is named based on the variable it generates (e.g., Alpha.do).

To ensure the reproducibility of the results, Tables 123.xlsx should not be deleted.

The main data used as inputs for the baseline and scenario calibration of the LTGM are taken from the default calibration the LTGM and LTGM-NR, which is discussed in detail (including data sources) in Loayza et al. (2022). Below we provide further details on key variables (listed in "Summary" tab of OUTPUT_default_nolinks_31March2023). We list the raw data sources here. We describe where one can download the data, and under which names they are called in.

Penn World Table 10

PWT version 10.01 is a database with information on relative levels of income, output, input and productivity, covering 183 countries between 1950 and 2019. We use data from PWT 10 to calibrate the labor share, initial capital to output ratio, depreciation rate and TFP. You can download PWT 10 from https://www.rug.nl/ggdc/productivity/pwt/?lang=en.

- Labor share. The labor share is a key parameter for the impact of human capital on growth and is taken from Penn World Table 10 (PWT10) for 2019 (most recent observation) under "labsh" "Share of labour compensation in GDP at current national prices"
- Depreciation rate is taken from "delta" the "average depreciation rate of the capital stock"
- Initial capital-to-GDP ratio. The initial capital-to-GDP ratio is calculated using the 2019 observations on physical capital stock and GDP from PWT 10. More specifically, we compute KY= rnna/rgdpna where "rnna" is "Capital stock at constant 2017 national prices (in mil. 2017US\$)" and "rgdpna" is "Real GDP at constant 2017 national prices (in mil. 2017US\$)"

World Economic Outlook (October 2022)

We set the path for investment equal to the IMF's World Economic Outlook (October 2022) from 2021 to 2027. The variable is "NID_NGDP" "Total investment, Expressed as a ratio of total investment in current local currency and GDP in current local currency". One can download the data here:

World Bank's Human Capital Project

The data for the HCI of young cohorts (5-19 year-olds in 2020-2021 and future cohorts) are taken from the World Bank's Human Capital Project, (which measures the expected LAYS a child born today is expected to attain by her 18th birthday (including quantity and quality of education, S_c and Q_c). Barro-Lee Educational Attainment Database

The data for the years of schooling of older generations is from the Barro-Lee Educational Attainment Database and can be downloaded here http://www.barrolee.com . The database is explained in details in Barro and Less (2013)

National Accounts Data from the UN's Statistical Division (UNSD)

To simulate future TFP growth paths we use the most recent data on the share of agriculture in total Gross Value Added reported by the UNSD. We use the ISIC3 classification. The data can be downloaded here:

UN's World Population Prospects

We use the UN's World Population Prospects forecasts for total population growth and the working-age population from 2021 to 2100.

World Bank's World Development Indicators

- The labor force participation rate is taken from the World Bank's WDI under
- "Labor force participation rate, total (% of total population ages 15-64) (modeled ILO estimate)" code SL.TLF.ACTI.ZS
- GDP per capita is taken from the WDI under "GDP per capita, constant 2015 US\$" code NY.GDP.PCAP.KD

<u>UNESCO</u>

The UNESCO data records for each day of 2020 and 2021 whether schools are fully closed, partially closed, or open. UNESCO codes days into "Fully Closed" and "Partially Closed" with the latter getting a weight of 0.5. You can download variables Fully Closed" and "Partially Closed" at UNESCO's dashboard on the global monitoring of school closures caused by the COVID-19 pandemic: https://covid19.uis.unesco.org/global-monitoring-school-closures-covid19/

Natural resources

Many countries in our sample are large natural resource exporters. For these countries, we apply the Natural Resource Extension of the LTGM (LTGM-NR). Key assumptions for the LTGM-NR are the initial reserves and discoveries of natural resources. Information on reserves is taken from the BP-Energy Dataset for oil, natural gas and coal; and from the U.S. Geological Survey Database (USGS) for mining industries, such as copper, gold, and iron.
