Reproducibility package for Equality of Opportunity for Sexual and Gender Minorities 2024

Purpose of this README

The purpose of this README is to guide users through the files and steps required to replicate the analysis and outputs presented in the Equality of Opportunity for Sexual and Gender Minorities 2024 report. This document details the structure of the replicability package, including dependencies, data sources, and instructions for executing the scripts and spreadsheets.

About the EQOSOGI 2024 Report

By assessing discrimination in laws, regulations, and policies, the Equality of Opportunity for Sexual and Gender Minorities (EQOSOGI) initiative examines institutionalized challenges encountered by sexual and gender minorities. This second edition of the EQOSOGI report expands its coverage from 16 to 64 countries ¹, representing different geographic areas, income levels, legal traditions, and inclusiveness of sexual and gender minorities, ensuring a diverse and holistic representation of the issues. EQOSOGI presents indicators to identify differences in the legal and policy environment for sexual and gender minorities in six areas: Decriminalization, Access to Education, Access to Labor Markets, Access to Services and Social Protection, Civil and Political Inclusion, and Protection from Hate Crimes. The indicators are also disaggregated into the three dimensions of sexual orientation, gender identity and expression, and sex characteristics.

The EQOSOGI report is a product of the Social Sustainability and Inclusion Global Practice of the World Bank Group. The project was led by Clifton Cortez and Julia Constanze Braunmiller. Samreen Shahbaz assisted in coordination of the project and supervised the legal data collection and analysis. Paola Ballon led and supervised the economic analysis. Dependencies

To ensure that the scripts run smoothly, it is necessary to install the wbopendata package in Stata. This package allows the scripts to access and integrate external indicators, such as those from the World Development Indicators, directly from within Stata. To install the package, run the following command in Stata:

ssc install wbopendata

Make sure that this package is installed before executing any of the master do-files to avoid errors during the replication process.

Contents of the Package

The replication package includes the following key components:

- Master Files: Located in the master files folder.
 - f1_user_profile.do: Allows the user to set the working directory. This step is crucial for running the other master files.
 - f2_inputs.do: Runs scripts to assemble the EQOSOGI 2024 dataset, integrating external indicators from Worldwide Governance Indicators, World Development Indicators, and Women Business and the Law.
 - f3_outputs.do: Generates the report's tables and figures in a clear, organized manner.
- Scripts: Located in the scripts folder.
 - EQOSOGI_database_ensambling.do
 - EQOSOGI_external_indicators.do
- Inputs: All inputs required to run the master files and scripts are included in this package.
 - Coding sheets for the 64 EQOSOGI 2024 countries.
 - Intermediate databases:

- Outputs: Once the f2_inputs.do file is run, the EQOSOGI 2024 dataset will be generated and stored in the outputs folder.
- Reproducibility in Excel: Contains all elements of the EQOSOGI 2024 report that can be replicated using Excel. This folder includes the following files:

Replication Instructions

To replicate the analysis, follow these steps:

- 1. Open the fl_user_profile.do file and set the working directory to the path where the replication package is extracted.
- 2. Run the f2_inputs.do file to process the data and assemble the EQOSOGI 2024 dataset.
- 3. Execute the f3_outputs.do file to produce the report's tables and figures. The outputs are organized clearly within this script.

Important: The master files must be run in the specified order: f1_user_profile.do first, followed by f2_inputs.do, and finally f3_outputs.do. After completing step 3, examine the contents of the Reproducibility in Excel folder to review the elements of the report that have been replicated.

Output Details

The EQOSOGI 2024 report includes a variety of outputs, all of which are ultimately edited in Excel. However, some of the values used in the tables and figures are first processed and generated using Stata. Specifically, the data required for constructing the following items is produced within Stata:
