Overview

This replication package and repository relates to the study "Human Rights for Combatting Corruption—And Vice Versa" by James Anderson, Akanksha Baidya, and Samuel Ruben Alexander Garoni of the World Bank. The package consist of:

- A Stata .do file for reproducing findings related to the World Values Survey. This was used for Figures 5-8 and Summary Figure C.
 - "replication code for human rights and corruption.do"
- An Excel file with the data and explanations related to Summary Figure B, Table 2, and Figures 2 and 3 (maps). In includes the data created by the authors based on the UPR documents; Country and regional data from the World Bank's Enterprise Surveys; and World Bank region and income classifications.
 - "Replication Tables and Figures.xlsx"

Data availability

All data used in the study are publicly available.

Data sources

There are three sources of data:

- 1. World Values Survey Wave 7, version 5.
 - a. Use: This was used for Figures 5-8 and Summary Figure C.
 - b. Citation, as instructed online:

- c. Filenames: The paper used "WVS_Cross-National_Wave_7_Stata_v5_0.dta" which was the latest available at the time. For the purposes of replication, a smaller dataset including only the necessary variables from version 5 is provided in the replication folder, as well as the code which generated that dataset. The smaller dataset is called "WVS_key_variables.dta".
- d. **Source:** The WVS data can be accessed at the World Values Survey website. Data, instructions for access, and questionnaires are publicly available here:

2. Compilation of mentions of "corruption" in the Universal Periodic Review (UPR).

a. **Use:** This was used for Summary Figure B, Table 2, and for Figures 2 and 3 (maps). For each country, the paper used the "National Report" and "Compilation of UN Information". The most recent report, through June 2022, was used for this purpose.

Mentions of corruption focused on the word "corruption", not proxies. Any mention was considered a 1, except for truly trivial mentions. (E.g., UNCAC included in the list of abbreviations but not referenced in the document.)

- a. Use: This was used for Table 2.

- Go to the links above for the raw data, download the listed files, and place them in the data folder; or use the dataset in the replication folder called "WVS_key_variables.dta", download and place in the data folder.
- 2. Open and update the following files with your directory paths: "replication code for human rights and corruption.do"
- 3. Ensure all required software and dependencies are installed as listed in the Requirements section.
- 4. Run the main_dofile.do file.

- 1. To replicate the designations related to the UPR documents, go to the link above for the individual country reports and search on the word "corruption."
- 2. To replicate the figures and tables based on the authors designations, download the Excel file "Replication Tables and Figures.xlsx"
- 3. Ensure all required software and dependencies are installed as listed in the Requirements section.
- 4. Open the Excel file to view the designations and the computations of aggregates.

Working with the raw data from the WVS requires the ability to access and manipulate a Stata data file that is 174,777 KB. This is easily managed on a PC. All other data files and are much smaller and easily managed on a PC.

- a. Using the WVS respondent-level dataset to extract key variables;
