### *Main findings*

- The code was successfully executed on a new computer after:
  1. changing file paths
  2. setting **set varabbrev on**
  3. adding sect2\_hh\_w4.dta to the ESS\_2018 folder via [microdata.worldbank.org](https://microdata.worldbank.org)
  4. modifying **Enterprises dofile5.do**, as noted in Code Suggestions, to make it compatible with Stata 14 for a smooth package run.
- The output demonstrates consistent stability across multiple runs. Specifically, executing the code two times consecutively yielded identical results.
- The code is found to be reproducible.

### *Reproducibility assessment*

- Paper exhibits were attempted to be reproduced on a computer with the following specifications:
  - OS: MacOS Ventura
  - Processor: Apple M1
  - Memory available: 8 GB
  - Software version: Stata MP 14.0
- We conducted our reproducibility analysis based on the paper shared by the authors in their reproducibility package *20231212-Ethiopia-presumptivetax*. Our validation involved comparing the results generated by the code with the exhibits in the paper to assess their consistency.
- Reviewers used data provided directly by the authors to verify the package (rather than requesting the data from the source)
